



# Bringing Health & Dental Together through Oral Health for Overall Health

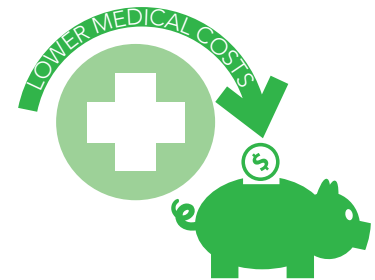
